



HEALTH PROTOCOL & BEST PRACTICES

The Objective of this plan is to contribute on our competitiveness, security of our products, services and processes; the protection of our people, travelers and the environment. We do consider in our whole process the integration of people with disabilities. We want to improve the control of our business risks, thereby contributing to the achievement of excellence in our operation and the well-being of society. This means we do have a firm commitment with risk management, leading the systematic implementation of measures aimed at minimizing it.

Due to this objective we created this prevention plan which includes an action/checklist for infection prevention and a special cleaning and disinfection plan. The whole risk management plan is part of all our processes, therefore, the different processes are coordinated with each other.

According to the guidelines established by the Costa Rican Ministry of Health and the I.C.T. (Instituto Costarricense de Turismo – Costa Rica Tourism Board), the following are the measures our company has implemented to protect our passengers and staff.

- IL VIAGGIO TRAVEL has implemented protocols to deliver a safe experience for our staff and guests through enhanced cleanliness and hygiene best practices.
- IL VIAGGIO TRAVEL has trained all our staff to prepare, answer questions, resolve challenges, share protocols and execute operational plans which include protocols, guidelines, tools and all the necessary information for infection control, physical contact, sharing of food and utensils, appropriate attire, and enhanced hygiene measures, the use of masks and gloves as recommended by local health authorities

• Certified Guides will give adequate information to our travelers

The tourist guide must assume a firm commitment to our risk management plan, executing the systematic implementation of the contingency measures defined for the prevention and reduction of hygienic-sanitary risks. Some details that should be given by our guides to all travelers:

- Guide and drivers have to use masks.
- We requests our passengers to bring their personal equipment.

- Our guides must remember the preventive measures implemented and urge that they be complied with for the sake and safety of all.







- Passengers should not travel if presenting any COVID-19-related

symptoms. If they do have symptons we have establish a verbal and written communication channels with our office and travelers, in the event that any have any symptoms related to a respiratory disease or have been close to a suspicious contact, to coordinate with the instances of corresponding health and contact line 1322.

- In our tours we reflect physical distance by limiting the number of travelers, and we do offer very good ventilation and open air

- Our guides will inform all our guests in regards to the hygiene protocols that they should follow. For example:

* they should wear masks during all transfers and tours.

* They will also inform passengers that before removing masks, passengers and staff must wash or sanitize their hands and place masks in a sealed bag. Before placing masks back on, hands should be washed or sanitized again. Masks should be removed before using restrooms or for meals. Hand washing protocol will be reinforced before and after meals, or any of the activities included in the itinerary.

- * avoid greeting with physical contact, including shaking hands, both to other staff and customers.
- * the safety distance should be respected (1.8 to 2m distance)

* Thoroughly wash your hands after sneezing, blowing your nose, or coughing or touching surfaces potentially contaminated

• We have implemented in our office:

- We have implemented protocols and guidelines for staff health, including health checks for our staff.

- In our office we reflect physical distance by limiting the number of staff, distance between desks, each person has their own desk (no sharing) and we do offer very good ventilation and open air.

- Our staff uses protection equipment (PPE) and will have wellness and temperature checks before every shift.

- For the disinfection of electronic equipment we use clorox wipes to disinfect daily.

- We have alcohol gel in our offices available for all







• Our daily operation, programs, transfers and tours follow the following guidelines:

- All of our itineraries are operated on social bubble, small, private groups. Maximum capacity of passengers will be determined according to the Costa Rican Ministry of Health.

- We provide clear and consistent information prior to our guests trip, during the journey and after the visit.

- All of the suppliers/partners included on our packages like restaurants, hotels, parks, transport partners and venues follow likeminded health and hygiene protocols and guidelines to protect guests and staff as required. As well we have requested in writing their protocols.

- We have implemented appropriate cleanliness and disinfection best practices:

* Our vans have 70% alcohol for the shoes

* Our transportation units and all equipment during tours and transfers will be sanitized thoroughly before and after each tour, and between services.

* Your luggage will also be sanitized to get in the van

* Each vehicle will carry a waste basket with a plastic bag for disposable masks, gloves, tissues, etc. Bags are properly handled and disposed by our staff at the end of the tour.

* Our vehicles will be equipped with a hygiene kit, including gel hand sanitizer (Alcohol 70%) and additional masks.

* Each vehicle will have clear signage of the cough & sneeze protocol, washing hands protocols and social distancing to follow.

* The A/C in the vehicle will be set as flow and not circulating. When possible and weather permitting, open windows will be preferable. A/C vents will be sanitized daily.







How to Handwash?

WASH HANDS WHEN VISIBLY SOILED! OTHERWISE, USE HANDRUB

Duration of the entire procedure: 40-60 seconds

Wet hands with water;



Right palm over left dorsum with interlaced fingers and vice versa;



Rotational rubbing of left thumb clasped in right palm and vice versa;



Dry hands thoroughly with a single use towel;



Apply enough soap to cover all hand surfaces;



Palm to palm with fingers interlaced;



Rotational rubbing, backwards and forwards with clasped fingers of right hand in left palm and vice versa;



Use towel to turn off faucet;



Rub hands palm to palm;



Backs of fingers to opposing palms with fingers interlocked;



Rinse hands with water;

When the hand hygiene indication occurs before a contact requiring glove use, perform hand hygiene by rubbing with an alcohol-based handrub or by washing with soap and water.

I. How to don gloves:







1. Take out a glove from its original box

2. Touch only a restricted surface of the glove corresponding to the wrist (at the top edge of the cuff)



4. Take the second glove with the bare hand and touch only a restricted surface forearm with the gloved hand, turn of glove corresponding to the wrist



5. To avoid touching the skin of the the external surface of the glove to be donned on the folded fingers of the gloved hand, thus permitting to glove the second hand

3. Don the first glove



6. Once gloved, hands should not touch anything else that is not defined by indications and conditions for glove use

II. How to remove gloves:



1. Pinch one glove at the wrist level to remove it, without touching the skin of the forearm, and peel away from the hand, thus allowing the glove to turn inside out



2. Hold the removed glove in the gloved 3. Discard the removed gloves hand and slide the fingers of the ungloved hand inside between the glove and the wrist. Remove the second glove by rolling it down the hand and fold into the first glove





4. Then, perform hand hygiene by rubbing with an alcohol-based handrub or by washing v
